## General Items:

Woman Lake Inspections for AIS - Rich spoke to us on the Inspection Grant applied for and received from the DNR. This would cover 375 hrs. @\$8.00 per hour being matched by Cass County funds of \$8.00 per hour for the inspector being paid \$16.00 per hour. DNR will train inspectors. This is for the Hwy. 5 access to woman Lake. Rich will also follow up on the Christmas Lake results.

No Wake signs going into Broadwater have been knocked down. Don will check on this.

Board will act on Catch and Release funds at May 21st meeting.

Road signs: 14 have been ordered. Don will let Dave know when they arrive. Jon Stevenson will help with signs. Signs need to be removed when members are no longer members or have moved.

Fisheries update: Rich informed us that Fall Gill netting and electroshock showed good size and numbers.

Traps were slow and not a lot of fish, the Cut Sioux trap was used to fill out quantity needed.

The 8 year study is now completed and we will be hearing more about it and another study.

McKeown Lake beaver dam problem is being monitored - lack of water now.

Shoreline Naturalization: Jim told us of the tree program and how it has grown. Very good quality of trees this year and he had 495 orders.

Water Patrol: Ted has opener covered with 2 crews per day. A new radio will be installed into the boat, have Sheriffs frequency but volunteers need to check in and out on their phone. Increase patrol on Fridays and Holidays??? Volunteers meeting date has not been set. Ted will be getting Ice Cream coupons.

Spring newsletter: John informed us that it is going well and will include the calendar of events. He has a good supply of articles for the newsletter and will need to sort. He thanked everyone for all their help.

Water Quality: Bob submitted a report to Don and it will be covered at the May meeting.

Membership: Myles has Josh Stevenson to speak at our Annual meeting on Woodland management.
