- f. Water Quality Gary reported that samples have been taken.
- g. Tree program Myles reported that the tree selection will be in the Fall newsletter.

- i. Stewardship/Conservation Vic's report stated that the ACCL is working to fund a fall resorters gathering to again listen and build a community among them. Resorters work to care for our waters and play a huge role in the local economy. M/S/P to donate \$300.00 for this Resorters gathering.
