Road Signs - 15 new ones are ordered. Two standards need to be rebuilt. Jon and Don are working on this. As of the June 1 membership list all of the non members name signs will be removed.

Fisheries and AIS - Rich - The MN DNR egg-take operations at the Boy River trap occurred from about April 11th - 17th. A total of 1,022 males and 573 females were collected and 393 females were stripped of their eggs. A total of 202 quarts of walleye eggs were collected. The walleye run in the Boy River appeared not to have peaked yet, but the DNR had reached its egg take goal and the trap was closed. Leech Lake is no longer being stocked, it is self sustaining.

Please note all anglers are asked to please report the tag number, location and date caught, length and whether the fish was kept or released via their interactive web page which can be found by searching "MNDNR Tagged Fish" on any search engine; tag reports can also be submitted by Email to: walker.fisheries@state.mn.us. In Longville the One Stop, Full Stringer Bait & Tackle, and the Mule Lake Store will have tag report booklets.
