# Conservation/Stewardship

Environmental Stewardship is something that we all can relate to when it comes to our place on the lake. If you have been on the lake for many years you have seen changes happen because of nature. To much rain, not enough rain, the impact of the Rusty Crawfish on vegetation, wind storms destroying our woods and causing erosion on the shorelines to name a few.

Our goal as an association is to promote protection and improvement of conditions on the lakes and waterways served by the association.

Last fall we started a shoreline buffer improvement and restoration program. We offered 5 native plants to all members to be used on their shorelines. We had over 50 members take advantage of this program. The information for next year will be in the fall newsletter.

By expanding your buffer area, planting vegetation and moving the lawn back from the shoreline, it will help to control runoff and contribute to the clean water we have. Maintaining good septic systems will also help to maintain the water quality in our waterways.

## Tim Bruhjell, Chairperson of Water Patrol

This report represents a compilation of the 2019 Woman and Girl Lake Volunteer Water Patrol activity starting on the Walleye Opener on May 11<sup>th</sup> continuing to mid-July. There are 17 volunteers four of which are new this season. Taking into account that the volunteers are scheduled for patrol on weekends and holidays, there have been 19 patrol days available since opening day. Total hours patrolled to date are 80, which is in line with the mid-summer total of past years. With approximately 2 months left in our patrol season, we should surpass the 200 hour mark by the end of the season. Volunteers patrolled for 215 hours in 2018.

The patrol boat was prepped for the 4<sup>th</sup> of July parade on the 3<sup>rd</sup>. After the parade the patrol boat was available and used to support the fireworks display the evening of the 4<sup>th</sup>. Approximately 6 hours of water patrol boat time was spent by the Cass County Sheriff's Office in support of the 4<sup>th</sup> of July fireworks event.

## Jon Stevenson, Chairperson of Road Signs

There are 43 standards around the chain of lakes that display the names of our members. If you know of a name that should not be on the standard please let us know. The member may have sold and moved or passed away. This year we replace 5 old signs. 12 new member name signs have been put up so far this year.

- 3. When it is finished it will be put up by Jon Stevenson. If the sign is ordered during the winter then it will be put up in the spring.

# Ann Stevenson, Chairperson of Water Quality

We continue to collect water samples from Child, Girl and Woman Lakes as part of a ten year study through RMBEL (RMB Environmental Laboratories, INC.) In 2018, RMBEL reported continued increase levels of Chlorophyll-A in Woman and Child Lakes with concurrent decreased water visibility per Secchi disk testing. Chlorophyll-A levels are influenced by nitrogen and phosphorus which are essential for plant growth. But when excessive nitrogen and phosphorus levels enter our water supply they tend to promote algae growth which reduces water clarity and visibility. By practicing good stewardship and minimizing run-off into our lakes and streams we hope to reverse this trend in the future. During the same testing period, no water quality changes have been identified for Girl Lake. A complete detailed report can be found in the Woman Lakes Chain website (www.womanlakechain.org). ## Rich Hess, Chairperson of Fisheries and Aquatic Invasive Species

#### **Fisheries**

#### **Boy River Egg Take**

The MN DNR egg-take operations at the Boy River trap occurred from April 19-26, 2019. A total of 380.6 quarts of walleye eggs were collected (52.6 million eggs). Encouraging, as per the DNR, were the number of 17-inch females observed in the trap for the first time along with many males as well.

#### **Woman Lake Gill Net Assessment and Electrofishing results**

A fall gill net assessment was conducted on Woman Lake from September 16-21, 2018. A total of 15 variable mesh gill nets were set and retrieved. The total catch included 140 walleye, 156 yellow perch, 77 Tullibee (Cisco) and 58 northern pike. Lesser numbers of other species were also collected. The walleye ranged from 7-24.5 inches in length and averaged 14.5 inches. Yellow perch ranged from 5-11 inches and averaged 6.5 inches. The northern pike ranged from 17-35 inches and averaged 24 inches. The Tullibee averaged 19 inches in length. The majority of walleye collected were of ages 1-5 years old.

The walleye catch rate of 9.3 per gill net met the long-range DNR management goal of 6-10 walleye per net. The northern pike capture rate was 3.9 per net and was below the management goal of 5-8 per net. The yellow perch capture rate was 10.4 per net and was below the management goal of 13 per net. The Tullibee capture rate of 5.1 per net exceeded the management goal of 2.0 per net. The next fall gill net assessment will be conducted in 2020.

The fall electrofishing assessment of young-of-the-year walleye was conducted only once on October 1, 2018. The total catch was 25 young of the year walleye. The catch rate of the walleye was 19.5 per hour, a decline of 17% from 2017. However, the 2018 fish were all greater than the 5.5 inch benchmark and averaged 6.6 inches. This larger average size gives them a better opportunity for overwinter survival and subsequent growth this year.

#### **Northern Pike Regulation**

The northern pike sport fishing regulation will remain unchanged for 2019 to allow for a further review by the DNR. The regulation remains at a possession limit of three; all pike from 24-36 inches must be released and only one pike over 36 inches may be kept. A public meeting is planned by the DNR later this year to receive input from anglers on whether to keep the regulation as it is or going to the proposed North-Central Zone limit of 10 pike. All pike from 22 to 26 inches must be immediately released and no more than 2 pike over 26 inches may be kept.

#### **Aquatic Invasive Species**

The Minnesota DNR lists a total of **1,057** infestations in approximately 770 bodies of water statewide through April 2, 2019. The invasive species in Cass County include *zebra mussels*, *Eurasian watermilfoil*, *and faucet snails*. There were no new infestations reported in Cass County in 2018 and through April 2, 2019.

As watercraft users we must all be careful to check our watercraft for invasive species before we launch them into a waterbody. Bait buckets must either be emptied in the trash or have water exchanged prior to leaving any waterbody, and drain plugs must be removed from all watercraft and all boating related equipment prior to transporting. There are now watercraft decontamination facilities in Cass County and there is no charge for decontamination.

## Linda Kane: Newsletter editor

The newsletter is an important way for us to communicate information about maintaining and improving environmental quality on our lake chain. Additionally, other topics of interest for our lake association members are included. Over the past year, we produced and distributed a spring and fall issue of Lake News to our members.
