Fisheries – Rich Hess No report. Aquatic Invasive Species – Rich Hess New Infestations: Zebra mussels were confirmed in Bowstring Lake (Itasca County), Long L. (Hubbard County), Pickerel L. (Ottertail County), and Long L. (Becker County). Eurasian watermilfoil was confirmed in Big Mantrap L. (Hubbard County). No additional zebra mussels or veligers were reported from Woman Lake. Eurasian Watermilfoil – Girl Lake: The city docks and Long Birch Lodge Harbor were treated July 30, 2020 by PLM. Signs informing the public were put up. A liquid herbicide called ProcellaCOR was used which is effective against both Eurasian watermilfoil and the hybrid cross between Eurasian and Northern watermilfoil (native to MN). Cost of the treatments was \$1,014.36.
